- The need to standardize the lane width from the existing 4.0m to 6.10m to comply with the minimum pavement requirements, hence, additional component CW-2;
- Modified project component from Reconstruction (Paved to Concrete) into Construction of Concrete Road since the Reconstruction of damaged pavement with shattered slabs/cracks was already undertaken by the LGU; and
- Provision of concrete barrier in order to improve travel safety since the road is along the shoreline.
