- Typographical error in the project name from "Prk. 13 Pro. 4" to "Purok 13 to Purok 4"
- Modified project name since the "with Bridge Component" in the project name was deleted infamuch as there is no existing waterway along the alignment of the road.
- Increase in physical target from 0.600 lane km to 1.380 lane km due to the following:

 Change in pavement design from 6.10 m width 230mm thk to 6.00 m width 230 mm thk, since the road is classified as a barangay road, not a city road.
 - The road runs in a combination of flat and rolling terrain which only requires minimal correction on vertical and horizontal alignment with an average height of only 1.0 m for embankment and 1.50 m for cut.
 - There is a need to extend the project limits to pave the remaining unpaved portion of the road.

Based on our evaluation, the herein request is found in order, hence approval is hereby recommended.
