## Justification:

Typographical error in the project name since as per RBIA, official road name is Davao-Sarangani Coastal Rd (Malalag-Malita-JAS-Glan) instead of Davao-Sarangani Coastal Rd (Malalag-Malita-JAS-G).

Adjustment in physical target (with considerable cost) and project component including non-inclusion of project limits due to the following:

- The last three original sections were already paved by Region XII as per actual survey (Region XII unintentionally went beyond the boundary since there is no existing km post);
- Adjustment on physical target for concreting is based on the remaining length and as per design since RBIA length is based on
  the measurement generated from actual topography while length of design is based on horizontal and vertical alignments.
  With higher unit cost for concreting since project design requires offsetting of horizontal alignment up to 16 meters since
  portion of the road traverses cliff section at one side, hence, with massive excavation (mostly hard rock) having average side
  cuts of 21 m; and
- Component costs for CW1 and EAO were adjusted based on the remaining length for concreting and total required amount, hence, with excess funds of P 45,190,000.

Based on our evaluation, the herein request is found in order, hence approval is hereby recommended.
