## Justification:

Modification in station limits from "K1589 + 1172 - K1590 + 280, K1590 + 340 - K1590 + 391" to "K1589 + 1172 - K1590 + 132, K1590 + 194 - K1590 + 282, K1590 + 342 - K1590 + 393, K1590 + 432 - K1590 + 666" due to the following:

- Modified original limits (2 sections) into three sections within the original limits to avoid sections along cliff sections which
  would requires slope protection. This is also to exempt sections with existing slope protection structures such as concrete
  slope protection and retaining wall. Redesigning these slope protection will also entail further soil investigation and huge
  funding requirement;
- Inclusion of adjacent section (4th section) which also needs widening (K1590 + 432 K1590 + 666); and
- · See attached Straight Line Diagram (SLD).

Increase in physical target for CW1-Road Widening from 0.772 lane km to 0.952 lane km due to the following:

- The road design does not involve slope protection and requires lesser earthworks (cut/fill) than initially considered to conform
  with the DPWH Design Guidelines and Standards (Horizontal and Vertical Alignment and Road Width), hence, lower unit cost,
  correspondingly, increase in physical target;
- Design for widening requires additional 2 lanes (2 into 4 lanes at K1589 + 1172 K1590 + 052, K1590 + 342 K1590 + 393, and K1590 + 432 K1590 + 666) and additional 1 lane only at 1590 + 052 K1590 + 132 and K1590 + 194 K1590 + 282 with 300mm thk PCCP (3,188.92 sq.m.) / 14-day concrete which also includes 150mm thk PCCP for paving of shoulders (.60m wide, with an area of 571.150 sq.m.) and transition ramps (120.130 sq.m.);
- Project also includes construction of drainage and slope protection structure with 0.6m x 0.8m lined canal (324.9 ln.m.) and 0.6m x 1m lined canal (371.1 ln.m.); and
- Inclusion of miscellaneous structures with metal guardrails (metal beam) including post (285.75 ln.m.), metal beam end piece (bull nose, 8 pcs), warning signs (3 pcs), and reflectorized thermoplastic pavement markings (white, with an area of 139.74 sq.m.) for edge lines and lane separator.
