## Justification:

- The original station limit of the proposed road widening was changed due to the opposition of the Congregation of the Church of St. Mary the Virgin in Sagada, Mountain Province (letter dated January 12, 2017 is attached for reference) despite request of this office to the congregation to reconsider the proposal (letter dated January 17, 2017 is attached), hence the new station limit at K0393+910 - K0394+040, K0394+415 - K0394+555, K0394+760 - K0394+820, K0395+665 - K0395+700, K0395+1870 - K0395+1922, K0395+2070 - K0395+2120.
- The project include construction of concrete barriers at the critical portions along these proposed new sections, construction of drainage which will prevent the area from flooding especially during heavy rain, and construction of retaining structures to meet the standard pavement width of 3.05 - 3.35 meters.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
