Justification:

The modification is hereby sought due to the following reasons;

- As per actual site inspection, K0117+800 –K0118+1215 need to prioritize to be overlaid because of its poor condition so we include this limits resulting in changes of station limits.
- Some sections have 4-lanes and to have a homogenous surface type of outer lanes was included for this section resulting in increase of the physical target. The released allocation is sufficient to cover the derived additional length.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
