## Justification

- Decrease in physical target was due to the derived unit cost based on approved POW and DED consolidated on the latest CMPD. The derived unit cost increases due to the inclusion of items of work required for the road opening of the section (Item 100(1) Clearing and Grubbing, Item 102(2) Surplus common excavation, Item 102(3)a Surplus Rock Excavation (soft), Item 102(3)b Surplus Rock Excavation (hard), Item 104(1)a Embankment from roadway excavation, common soil and Item 105(1)a Subgrade Preparation, Common Material). Said items for the road opening were critical for the section since it was located in a mountainous area.
- The proposed road opening will cover the full road right of way of the alignment for the 1,303 lineal meter of road section with a design carriageway width of 11.7 meters. Also, provision of Slope Protection Structure (Stone Masonry) with drainage (ditch) is included in the scope of the project.
