Justification:

- Modification of the project title to Construction of Box Culvert along Balanti Creek, Brgy. Sta. Elena, Marikina City (Phase I) to attain what is beneficial to the constituents of Marikina City and to complete the Phase I of the proposed RCBC project from Katipunan extension to Gil Fernando Avenue;
- The proposed project entails a higher construction cost due to its new design resulting to a shortened physical target. The new scope of work involves the construction of a reinforced concrete box culvert along Balanti Creek that will convey flood water more effectively to its outfall along Gil Fernando Avenue;
- Furthermore, the proposed project when completed shall be converted to a 2-lane road and shall be utilized as an alternate route for light vehicle bound to Sumulong Highway to decongest the worsening traffic situation along Gil Fernando Avenue – Sumulong Highway Intersection.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended to the Secretary.
