Justification: To identify the project work components; CW-1 Widening of Bridge, and ROW Acquisition. The original unit cost of the project was derived from the amount involving civil works and road-right of way acquisition while the unit cost in the new project components, CW1 and ROW are derived separately and specifically for each component. The change in target from 137.25 to 135.00 Sq.m. is due to change in the proposed bridge width from 9.15 to 9.00 lineal meters.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
