JUSTIFICATION:

Station limits of the project as reflected in the FY 2017 GAA did not change, however, the physical target was decreased based on the actual field requirements and program of work. Considerable cost in the shoulder paving due to the increase in the unit cost of aggregates caused by the triple handling wherein the total hauling distance from the quarry site (Anao-aon, Surigao City) to project site is 96 km, resulting in the reduction of the physical target by 5,061 sq.m. (from 25,305 sq.m. to 20,244 sq.m.). Thus, the request for modification.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Program of Work, Location Map, Certificate of Availability of Funds (CAF) and Geotagged Photos.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
