**JUSTIFICATION:**

Modification is requested due to the use of the Steel Sheet Piles (9.0m length) which accounted to 78.30% (P28,556,262.16) of the total project cost resulting to the shortening of the physical target by 1,747.97 sq.m. (from 3,831 sq.m. to 2,083.03 sq.m.). Further, the scopes of work involves the provision of concrete shoulder which is necessary to prevent scouring and protect both the slope protection structure and carriageway and provision of guardrails especially at the curve sections to ensure safety to the motoring public.

Attached are the required documents, such as Evaluation Form (2017, version 2.1), Approved Program of Works (POW), Certificate of Availability Funds (CAF), Geotagged Photos and BP 202.

In view of the above, the request for Modification of Project is respectfully recommended for consideration and approval.
