Increase in physical target from 2.500 Lane Km to 4.750 Lane Km were due to:

- The actual terrain is a combination of rolling and mountainous (mostly rolling) as per actual site condition instead of the anticipated mountainous terrain for the entire stretch.
- Typographical error in the project description wherein the word "incl. ROW" was inadvertently included in the FY 2018 GAA but no corresponding component. Also, there is no need for Acquisition of Right of Way in this project, hence, ROW is deleted in the project name.
