Justification: Modification is requested to change the station limit and considered to prioritize Sta. 56+910.95 – Sta. 56+984.30 of the same location instead of 0+238.75-Sta.0+349.39 as provided in the FY 2017 GAA based on the actual site assessment/evaluation. The decreased in physical target resulted to an increase in the unit cost from P168.58T/Lm to P254.29T/Lm based from the approved Plans, DUPA and POW.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
