Justification:					

Justification

Increase in physical target for concreting from 0.882 lane km to 1.240 lane km due to the following:

- The road runs on a very flat terrain and design is on-grade, hence, requires very minimal earthworks (cut/fill) only to conform with the Design Guidelines and Standards (Horizontal and Vertical Alignment and Road Width). As such, project limits extended to cover adjacent sections which also needs to be paved; and
- Design involves 0.23m thick of Portland Cement Concrete Pavement (PCCP) on a 14-day concrete curing for the 2-lane road with 5m width

Based on our evaluation, the submitted request for modification is in order, hence, it is respectfully recommended to the Secretary for his consideration and approval.
