JUSTIFICATION:

There is no change in physical target but project allocation was increased from P56,675,000.00 to P 63,664,980.00 for Civil Works due to inclusion/provision slope protection, construction of drainage up to outfall, removal and reinstallation of traffic signalization and additional lane into 7 lanes right side for 0.660 km in order to prevent accident from scouring that will result to damage of structures. Decrease in allocation for RROW acquisition from P 24,857,000.00 to P 17,862,000.00 due to reduction of area which is to be acquired from 6,030 sq. m. to 4,500 sq. m. Thus, this request for modification.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP 202, Certificate of Availability of Funds (CAF), Approved Program of Work, and Geotagged photographs.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
