JUSTIFICATION:

Physical target was decreased by 0.356 lane km (from 3.326 lane km) to 2.970 lane km) since the portion of the road section (K1700+838-K1700+981) was excluded inasmuch as widening of said road was already covered under on-going 2015 bypass project. Also, end of limits was modified since K1701+970 is located already at the junction. Although physical target was shortened, the allocation was just sufficient to cover the needed widening along the road section due to thickness of pavement 40 bx used (320mm) and considerable amount needed for drainage structures, sidewalk, curb and gutter, provision of thermoplastic pavement markings, road signs, coconet and coco logs.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Certificate of Availability of Funds (CAF), Approved Program of Work, Straight Line Diagram and Geotagged photographs.

In view of the above, the request for Modification of the Project is respectfully recommended for the Honorable Secretary's approval.
