JUSTIFICATION:

There is no change in project limits, however, the physical target for widening just shortened based on actual design length. The area for slope was decreased by 3,942 sq.m. (from 6,470 sq.m. to 2,528 sq.m.) based on the actual need. Further, there is considerable amount for slope protection since the design of slope protection are retaining and catch wall inasmuch as additional 2 lanes is concentrated at one side only. There is also an additional project component which is the asphalt overlay of existing 4 lanes since the road is in fair to poor condition (presence of wearing, longitudinal and transverse cracks and cracked slabs) in order to restore into its original good condition. Attached is a copy of Visual Road Condition Assessment Form (as of Nov. 2016) for information and ready reference.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP-202, Certificate of Availability of Funds (CAF), Approved Program of Work, Straight Line Diagram and Geotagged photographs.

In view of the above, the request for Modification of the Project is respectfully recommended for the Honorable Secretary's approval.
