JUSTIFICATION:

Modification is requested due to the changes of station limits. The limits for Paving of Shoulders as per GAA has been covered and even extended, however, the decrease in area covered is due to the change of design width (originally 2.50m. to a variable of 1.50m. to 2.50m.) based on actual field validation. The excess amount was utilized for the construction of slope protection (185.92 sq.m.) which is also needed along the road including improvement/concreting of junctions (10 sites) to provide smooth transitions of pavement to interior areas within the roadway section, hence, an increase of unit cost.

The end of original limit/end of national road (K1700+660) was extended to K1700+664.922 in order to improve the junction of the national road connecting the local road.

Attached are the required documents, such as Approved Plan, Approved Program of Works, Form for the Evaluation of Modification Request (2017, version 2.1.), Certificate of Availability of Funds (CAF), Approved Budget for the Contract (ABC), BP 202, and Geo-Tagged pictures.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
