JUSTIFICATION:

Modification is requested due to the increase in physical target of concreting to connect with the proposed end of concreting of approaches in an on-going bridge project for the 1^{st} section (K1544+990 instead of K1544+987) and to include portions of the local road connecting the national road for the 2^{nd} section (K1546+140 instead of K1546+135).

Some portions of the road have wide carriageway which do not require massive excavation. With this, the excess amount was utilized for the paving of shoulders equivalent to 8,185.69 sq.m. These paving of shoulders is also needed along the road to prevent degradation of shouldering materials during heavy downpour.

The Paving of Shoulders of the 1^{st} section (K1544+172.862 – K1544+990) is the gap between existing paved shoulders while the 2^{nd} section (K1545+320 – K1546+140) is the same limit for the concreting.

Attached are the required documents, such as Approved Plan, Approved Program of Works, Form for the Evaluation of Modification Request (2017, version 2.1.), Certificate of Availability of Funds (CAF), Approved Budget for the Contract (ABC), BP 202, and Geo-Tagged pictures.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
