## JUSTIFICATION:

There is no change in physical target, only project limits.

Station limits modified to Sta. 7+250-7+778 (right bank) to prioritize a more critical section to address immediately the continuous scouring/erosion at said section which already caused damage/collapse of the road. The said section is constantly subjected to the current of the river due to the meandering course of the river which causes the continuous erosion of the bank. Hence, the need to immediately address the said section to prevent further scouring and protect the lives and properties along the area.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP 202, Certificate of Availability of Funds (CAF), Approved Program of Work, and Geotagged photographs.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
