JUSTIFICATION:

There is no change in project limits but with increase in physical target from 708.00 Im to 1,416.00 Im due to change in design going to outfall. The original design involves construction of spillway; however, said structure was already included under maintenance works, hence, generated excess amount shall be utilized to cover the needed drainage structure going to outfall and augment the existing flood control structures to mitigate flooding, prevent further scouring and protect the properties and residents along the area.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP 202, Certificate of Availability of Funds (CAF), Approved Program of Work, and Geotagged photographs.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
