## JUSTIFICATION:

Ancrease in physical target from 3,340 Im to 3,345 Im to cover the needed drainage structure to outfall. Station limits were modified to Chainage 2424 to pass thru Jct. Tulip to outfall, in order to immediately address the needed improvement of drainage from national road going to outfall. There is a need to address the drainage going to outfall in order to have a definite outlet for run-off water/drainage especially along national road to prevent

the flooding (0.30m to 0.80m depth during heavy downpour) along the area. In addition, this will also complement/connect with the previously constructed drainage that will also minimize flooding, thus, this request for modification.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP 202, Certificate of Availability of Funds (CAF), Approved Program of Work, and Geotagged photographs.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
