JUSTIFICATION:

Modification is requested to change the scope of work from Widening of Libby Bridge into Construction of Parallel Bridge and approaches including RROW were the said bridge is identified as "Tulay ng Pangulo" or Steel Bridge. It is decreed by law that it should not be dismantled. Thus, it was decided that the construction of new bridge will be made upstream instead on the downstream of the old bridge in order to evade the affected structures. And also, it is required to elevate the said bridge to prevent over top from flooding.

As per changes in physical target, it is desirable to consider only the bridge component, excluding the approaches of the bridge. Since the original physical target includes approaches, thus, it was reduced from 1,973.74 sq.m. to 117.12 sq.m.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP 202, Certificate of Availability of Funds (CAF), Approved Program of Work, and Geotagged photographs.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
