JUSTIFICATION:

The cost for the off-carriageway improvement for Tigbawan Bridge is only minimal, hence, was incorporated in the cost for the widening of bridge. Decrease in physical target (in square meters) due to change in bridge design width from 9.56 lm to 8 lm based on the approved

plan. Considerable cost for widening of bridge due to inclusion of other scopes of work such as widening of approaches including off-carriageway improvement, abutment protection, bank protection and installation of thermoplastic pavement markings.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP 202, Certificate of Availability of Funds (CAF), Approved Program of Work, Straight Line Diagram and Geotagged photographs.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
