## JUSTIFICATION :

Increase in physical target (area) by 101 sq. m. (from 3,455 sq. m. to 3,556 sq. m.) but decrease in terms of length that resulted in the revision of 3rd section from K1749+770 to K1749+725. The original target was computed using a 1.5m width of off-carriageway throughout the whole stretch of the project while based on actual site condition, the width needed for the off-cariageway improvement for the 3rd section is 3m for right and 2.3m for the left side (there is an existing lined canal at left side). Thus, this request for modification.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP 202, Certificate of Availability of Funds (CAF), Approved Program of Work, Straight Line Diagram, and Geotagged photographs.

In view of the above, the request for Modification of the Project is respectfully recommended for the Honorable Secretary's approval.
