Justifications as provided by the Implementing Office:

- Increased in unit cost due to the designed slab for the proposed reconstruction which is 350mm with reinforcement in order to for the new concrete pavement to withstand the load carried by heavy loaded vehicles that often passes the road section.
- Due to the corresponding increase in the unit cost, the allocation will not be sufficient to cover the entire original station. Therefore, end station was adjusted from K0048 + 876.5 to K0048 + 640.
- Change in type of work, the original type of work is not applicable in the P/A/P of the project as listed in the FY 2025 GAA. Therefore, it is corrected to Reconstruction from Paved to Concrete.
