

#### Justification:

The project is to be modified in view of the following:

The increase in the physical target is due to the inclusion of upslope protection (gravity wall)to prevent landslide and adjustment of height for the single crib wall structure to fully stabilize the road. The decrease in the unit cost is due to the lesser quantities of PART C- Earthworks and PART H – Miscellaneous Structures incorporated in the program.

- Change in the project limits to synchronize with the increase in the physical target and to connect with the project ID: P00800926LZ (Apayao-Ilocos Norte Rd K0658 + 820 K0659 + 050).
- Inclusion of CW2 Construction of Drainage Structures along Road is required to address surface water run-off and ensure proper water disposal to prevent pavement damage.
- The derived unit costs were based on the validated and approved DUPA and POW.
