

Justification:

The project is to be modified in view of the following:

- The change of station limit from Sta. 325+450 Sta. 325+685 to Sta. 325+444 Sta. 325+685 to cover the actual area that require flood control mitigating structure.
- The change of station limits from station 325+080 Sta. 325+250 to Sta. 332+180 Sta. 332+350 is . due to the latter section being more critical in terms of scouring. There is a need to address the further scouring to protect agricultural lands from further degradation.
- The decrease in unit Cost/ Increase in physical target of CW1-Construction of Flood Mitigation Structure is attributed to the lesser cost of earthworks considering the lesser volume that was ascertained through actual field survey.
- The derived unit cost is based on the validated Approved Program of Work (POW) and the Detailed Unit Price Analysis (DUPA).


