Justification:

- The decrease in the component cost for CW1 Road Widening was made to allocate additional funds for Right-of-Way Acquisition. This result to the removal of road sections K1780 + 442 - K1780 + 466, and K1780 + 475 - K1780 + 750, thus the decreased in physical target.
- The decrease in physical target/ increase in unit cost is due to;
 - √ The scope utilizes the design of a 280mm-thick PCCP with a consistent 7.6-meter width across the
 entire stretch, incorporating a 14-day curing period to ensure the concrete attains its desired
 strength.
 - ✓ The project involves substantial volume earthworks which constitutes 9.38% (P 10.837,447.54) of the total project cost.

- ✓ The project includes the construction of 6-meter width, 0.23m thick PCCP sidewalk and Bike Lane.
- ✓ Additionally, the design involves the construction of 108-linear meter lined canal with cover and 120-linear meter pipe culvert (910 mm diameter).
- The road design also includes reflectorized thermoplastic pavement markings (White and Green), road safety barrier system, and tubular markers.
- The change in Right-of-Way area is based on the result of the conducted parcellary survey.
- The change in the station limits was made to synchronize with the decrease in the physical target. See attached Straight Line Diagram.
- The derived unit cost is based on the approved Program of Works (POW) and Detailed Unit Price Analysis (DUPA).

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
