Justification:

The increase in physical target/ decrease in unit cost is due to;

- The minimal correction on the vertical alignment requiring lesser works for earthworks, contributed ₱ 3,618,141.25 (9.74%) only of the total project cost.
- The design reduced the need for extensive ground preparation, with 100mm thick (compacted volume of common soil) for sub base, reducing both time and material requirements, allowing for a longer stretch of road to be constructed within the allotted funds. See Attached Straight Line Diagram (SLD).

- Change in station limits to consider the sections requiring immediate rehabilitation, due to its deteriorating state, based on FY2024 RoCond data, resulting to the increase in the physical target.
- The derived unit cost is based on the approved Program of Works (POW) and Detailed Unit Price Analysis (DUPA).
