Justifications provided by the requesting Implementing Office:

- 1. Decrease in physical target due to the reconstruction to concrete pavement being applied only to the inner lanes at all stations.
- 2. Removal of unsuitable soil and materials beneath the existing pavement will require larger quantity of new embankment material than initially projected.

Attached are the following supporting documents: Annual Infrastructure Program (AIP 2025), Form for Evaluation of Modification Request (DPWH-QMSP-03-01 Rev 01), Certificate of Reasonableness of Cost Estimate, Certificate of Availability of Funds (CAF), Geotagged Photos, Location Map, Approved Program of Works (POW), Detailed Unit Price Analysis (DUPA), Detailed Engineering Design (DED) Plan, and Straight Line Diagram (SLD).
